

# Beach Ave Boxers

## Stud Contract

This agreement, dated as of \_\_\_\_\_, 20\_\_\_\_, is between Beach Ave Boxers, the stud owner, and \_\_\_\_\_, the bitch owner. The subject of this Agreement is the breeding of the bitch and stud dog listed below.

## 1. Compensation

- a. Stud Fee: Bitch owner agrees to pay Beach Ave Boxers a [non-refundable] stud service fee of \$\_\_\_\_\_ for stud services performed by this Stud Dog. All payments due under this Agreement shall be made up front, unless otherwise agreed upon. No payments made via bank wire or personal check will be accepted. Cash, or a secure payment through our Good Dog is fine.
- b. Stud Fee Puppies: Beach Ave Boxers has the right to \_\_\_\_\_ puppy(ies), which will be selected by Beach Ave Boxers and be 1st pick(s) of the litter. The stud fee puppy(ies) must be selected within \_\_\_\_\_ weeks of the puppies being born. Bitch owner agrees that the stud puppy(ies) will be released to Beach Ave Boxers with registration paperwork, without registration/breeding right limitations, and with exclusive naming rights that may or may not include the Bitch owner's kennel name.

## 2. Breeding

- a. This breeding will be a: natural breeding\_\_\_\_\_, artificial insemination\_\_\_\_\_, or fresh/frozen semen samples provided\_\_\_\_\_.
- b. Both Bitch and Stud Dog will test negative for Brucellosis within 72 hours of the Breeding.
- c. Repeat Breedings: Beach Ave Boxers does not guarantee that any puppies will result from the Breeding; Should no puppies result from the Breeding, Beach Ave Boxers agrees to provide one repeat breeding to the same Bitch (or other bitch owned and selected by Bitch Owner and acceptable to Beach Ave Boxers) to the same Stud Dog on the Bitch's next heat cycle OR refund the Stud Fee, at the Breeder's discretion. Should a repeat breeding be offered and not result in any puppies, the Bitch Owner will be refunded the Stud Fee and be free of any obligations relating to Stud Fee Puppies.

- d. Expenses: Bitch Owner agrees to pay all expenses incurred for the purpose of the Breeding at the time they are incurred unless otherwise noted in this agreement. This includes, but is not limited to, transportation of the Bitch, progesterone tests, semen collection and/or shipping, and all veterinary care costs and expenses related to the Bitch and her whelps.
- e. Emergency Care: If the Bitch is in the care of Beach Ave Boxers, the Bitch Owner hereby grants Beach Ave Boxers permission to authorize veterinary services for the Bitch in the event of an emergency or her health appears to be in jeopardy. Bitch Owner is responsible for any veterinary costs incurred.

### **3. Litter & Whelping Obligations**

- a. Notifications: Bitch Owner agrees to notify Beach Ave Boxers results of pregnancy tests, as well as birth of/number of puppies. Notifications will be made in writing within 48hrs (via email, text, message is okay).
- b. Vaccinations & Exams: Bitch Owner accepts full responsibility to ensure that all offspring resulting from the Breeding are treated for parasites, worms, and receive vaccines deemed appropriate and necessary by their veterinarian.
- c. Docking & Dew Claws: Resulting puppies from this Breeding are to have tails docked and dew claws removed no later than 3 days post-birth (if applicable).
- d. Stud Dog Owner agrees to help with the placement of puppies if requested by the Bitch Owner.

### **4. Bitch Owner Obligations:**

- a. Bitch: The Bitch Owner agrees that the Bitch is healthy, of sound and stable temperament, disease and parasite-free, and will be groomed and bathed before the it brought to be bred.
- b. Documentation: The Bitch Owner agrees to provide Beach Ave Boxers with proof of current vaccinations\_\_\_\_, a 3-generation

pedigree\_\_\_\_, and proof of genetic results for Degenerative Myelopathy\_\_\_\_ prior to the Breeding to ensure health and prevent inbreeding.

- c. Bitch Owner is obligated to bring Bitch to Beach Ave Boxers for breeding, unless artificial insemination or collection is agreed upon.
- d. Bitch Owner agrees to register the resulting litter with the AKC.

#### **5. Breeder Obligations:**

- a. Stud Dog: Beach Ave Boxers certifies that the Stud Dog is healthy, of sound and stable temperament, and disease and parasite-free.
- b. Documentation: Beach Ave Boxers agrees to provide the Bitch Owner with proof of current vaccinations\_\_\_\_, a 3-generation pedigree\_\_\_\_, and proof of the Stud Dog's current health screens (health screens to include a minimum of ARVC & DM results)\_\_\_\_.
- c. Registration: Beach Ave Boxers agrees to sign and return AKC litter registration promptly, as long as all requirements and compensation set forth within this agreement have been fulfilled.

#### **6. Miscellaneous**

- a. Confidentiality: Bitch Owner and Stud Dog owner agree that in the event of a dispute between them, neither will publish or communicate the existence or content of such dispute in any media or social media.
- b. Arbitration: All claims and disputes arising under or relating to this Agreement are to be settled by binding arbitration in the state of Wisconsin or another location mutually agreeable to both parties.
- c. Breach of Contract: Any violation of any provision above, any nondisclosures or omissions made pertaining to this Agreement, or any failure to perform any covenants provided in this document shall constitute a breach of this Agreement. Should the Bitch Owner breach this Agreement, the Bitch Owner will be held liable for a minimum of \$1,000 in compensatory damages, or \$500 per whelp in the event of a resulting litter sired by the Stud Dog.
