

Beach Ave Boxers

Health & Buy-Back Guarantee

Parties:

This agreement is made between Beach Ave Boxers (Breeder), and _____ (Buyer), for the purpose of setting forth the eligibility terms and conditions of Beach Ave Boxers' Health & Buy-Back Guarantee (referenced in Purchase Contract [Agreement]) regarding _____/("puppy/dog").

I. Health Guarantee:

Beach Ave Boxers guarantees this pet from life-threatening congenital defects for a period of 2 years from its date of birth: D.O.B. _____ Expiration: _____

Beach Ave Boxers also guarantees your puppy is free of Parvo, Coronavirus, and Distemper for 72 hours after leaving our care. Anything later could be caused externally, and we will not be held liable. These conditions are extremely contagious, and if diagnosed, the Buyer agrees to notify the Breeder immediately.

Environmental Factors:

Environmental factors may cause some disorders. These include but are not limited to Coccidia, Giardia, Kennel Cough (Infectious Tracheobronchitis), Diarrhea, parasites (including worms), Demodectic Mange, Scabies, allergies, fleas, ticks, mites, and autoimmune disorders and are not covered in this guarantee; These afflictions are very common, can be caused by external factors, and can be contracted after the puppy leaves our care. Although not covered under this Guarantee, your puppy has still received preventative treatment for worms, Coccidia, and Giardia; details are outlined under "Immunizations".

Our puppies are vet-checked prior to leaving our care and you will be provided with their medical records and fecal exam. Any and all health concerns or medical findings will be disclosed and discussed prior to you taking possession of your puppy. Any such findings will be noted in this Guarantee below.

Additional Exclusions:

Our guarantee does not include uneven bite/teeth, allergies, undescended testicles (cryptorchidism), recessed vulvas, Class I to II heart murmurs, umbilical hernias, stenotic nares, ectropion, or cherry eye. We don't knowingly breed these conditions, but they can happen.

Immunizations:

Your puppy has been dewormed at 2 weeks old and bi-weekly until 8 weeks with Pyrantel Pamoate and Fenbendazole. It may have received preventative doses of Toltrazilil as early as 3 weeks old. It also received its first round of core vaccines including Distemper, Adenovirus 1&2, Parainfluenza, and Parvovirus. Records have been provided to you. A 2nd & 3rd (maybe 4th depending on your vet) booster for DAPP will be necessary between 10 & 16 weeks, as well as Rabies around 16 weeks of age. We highly suggest adding Leptospirosis (Lepto) & Lyme to your vaccine schedule. Your vet will be able to advise on vaccine schedules and discuss with you what's best for you and your puppy as far as recommended boosters and timing.

It is the Buyer's responsibility to have the puppy checked by a licensed veterinarian and continue an appropriate vaccine schedule and routine general care.

Spay/Neuter:

Beach Ave Boxers does not require you to spay or neuter your dog. If you choose to do so, you agree not to alter your puppy before the age of 12 months, unless deemed medically necessary by a licensed veterinarian. Medically unnecessary spays or neuters prior to 12 months of age will void this Health Guarantee.

II. Buy-Back Guarantee:

If your puppy is found to suffer from a life-threatening congenital defect within the first 2 years of life, Beach Ave Boxers will replace the puppy in exchange for the return of the puppy, issue a refund of the original purchase price in exchange for the return of the puppy, or issue monetary compensation (amount dependent on condition and at Breeder's discretion) to offset costs of medical expenses related to the condition should the Buyer want to keep the puppy. The condition must be found, certified, and outlined in a written statement by a licensed veterinarian. Breeder reserves the right to confirm results with a 2nd licensed veterinarian of Breeder's choice prior to taking any action. Both Breeder and Buyer must agree to which compensation is appropriate.

If at any time the Buyer cannot or does not want to maintain ownership of this puppy, Beach Ave Boxers will take the puppy/dog back and/or assist in rehoming it at no cost to the Breeder. **There is no age limit or expiration to this term.** We will always take our dogs back for any reason, no questions asked. Any puppies or dogs returned will forfeit ownership and registration must be transferred back to Beach Ave Boxers (we will assist).

This puppy/dog is NOT to be rehomed or resold without the express written consent of Beach Ave Boxers. If for whatever reason your puppy is not a good fit for your home, please contact us immediately and we will help. We don't want our dogs ending up in shelters or unfit homes; contact us and we will help without any judgment. Refunds will be available in the form of the rehoming fee passed onto the Buyer once the puppy/dog is appropriately rehomed to their new family less any rehoming costs. Alternative refunds may be available at Breeder's discretion. Breeder has explicit first right of refusal to the puppy/dog and will assist in finding a suitable home if necessary. Breeder requires to know the contact information for any new family. Breeder will resume possession and ownership of the dog/puppy if a proper home cannot be found otherwise.

Death of a Puppy:

In the unlikely event of your puppy's death within the first 2 years, Beach Ave Boxers will issue a replacement puppy of equal value or a full refund of the original purchase price if the cause of death is deemed to be congenital or hereditary. The Breeder has sole discretion as to whether a replacement or refund is offered. A written statement from a licensed veterinarian confirming such an event, with a full autopsy and lab findings, is required at the Buyer's expense prior to the Breeder taking any action. Breeder reserves the right to confirm autopsy results with a 2nd licensed veterinarian of the Breeder's choosing prior to taking any action.

In the event of an accidental death of the puppy (within the first 2 years of life), Beach Ave Boxers will issue a credit in the amount of 50% of the original price toward the purchase of a replacement puppy of equal value from Beach Ave Boxers. A death certificate from a licensed veterinarian MUST be presented to the Breeder within 36 hours of the accident.

In the event of a preventable or negligent death of the puppy, Beach Ave Boxers will issue no refunds or compensation and is relieved of any and all guarantees and obligations related to your puppy.

III. Limitations of Guarantees:

There is absolutely no limitation on our rehoming portion of this Guarantee. We will ALWAYS take our dogs back. We will ALWAYS help them get rehomed. We're extremely reasonable and will do our best to make it right for everyone involved. The priority here is the dog!

Any signs of abuse, neglect, or mistreatment will automatically void these guarantees and consider the Buyer ineligible for any refunds, compensation, and future puppies. Mistreatment, abuse, and neglect are considered breach of contract by the Buyer.

Puppies that have not received routine and recommended veterinary care do not qualify for the Health Guarantee. Failure to vaccinate your puppy for Rabies or Parvo at the appropriate times will void the Health Guarantee.

Your puppy is required to be checked by a licensed veterinarian within 3 days of leaving the Breeder to qualify for the Health Guarantee. _____ (initial)
